Information regarding processing of personal data

Cross Border Cooperation Regional Office Calarasi for Romania-Bulgaria Border, with the headquarters - part of the main building representing the Passengers and Goods Transport Public Service headquarter of C.B.C.P Calarasi (Romania) - Silistra (Bulgaria), Calarasi County, as Operator, is informing you, that with your participation at the On site visit organized by CBC ROC, your personal data will be processed, such as: pictures, audio-video recordings, surname and name.

CBC ROC will process above mentioned data for dissemination of the information regarding the event in online media, social network services like Facebook, own website, online and printed media publications etc.

According to Law (EU) 2016/679, you benefit from following rights:

- Right to information you can request information regarding the activities of your personal data processing;
- Right to rectification you can ask for modifications for the inaccurate personal data or you can fill in the missing data;
- Right for your data to be deleted "Right to be forgotten" you can request for your data to be deleted;
- Right to restrict the processing you can ask to restrict the processing of your data;
- Right to object you can object the processing of data, especially the data that is opposing the law;
- Right for data portability you can receive, in certain conditions, the personal data you provided, in a machine-readable electronic format or you can request for data to be transferred to another controller;
- Right to fill in a complaint you can fill in a complaint regarding the means your personal data is processed to The National Supervisory Authority For Personal Data Processing;
- Right to withdraw consent in case the processing of personal data was a previously given consent, you can retrieve it anytime. The retrieval of the consent will take effect only for the future, the processing until the withdrawal will be still valid;
- Additional rights regarding the automated processing: you can request and receive human intervention for the respective processing, you can express your own point of view regarding the processing and you can contest the decision.

Your request will be resolved within maximum of 30 calendar days from the reception by the Cross Border Cooperation Regional Office Calarasi for Romania-Bulgaria Border.
